On April 17, 2002 Investigator Steve Porter contacted Deputy Thomas Goettel of the Pinellas County Sheriff's Department regarding his involvement in this case.

Deputy Goettel states he was dispatched to the Helen Ellis Hospital in reference to a shooting victim. Deputy Goettel met with officers of the Tarpon Springs Police Department who stated the shooting occurred within the city limits of Tarpon Springs. Deputy Goettel was requested to check their dispatch log to see if there were any calls to the Shades Bar which met with negative results. Deputy Goettel received the above stated call at 03:33 a.m. The Shades Bar had been closed for an hour and a half. Deputy Goettel states he also checked out an incident
