I was dispatched to the occurred location in reference to a threatening phone call.

Upon arrival I spoke with the complainant/victim, Edward Werda. Edward advised that he is a waiter at the Palms Bar and Grill and during his shift, he received a threatening phone call. Edward related that an unknown male told him that he would be killed when leaving the bar after his shift ended. Edward related that he didn't recognize the male's voice, but advised it could have possibly been a subject by the name of Dan (NFI). Edward couldn't provide any further information on Dan. He stated the incident may be in reference to an on-going homicide investigation from Tarpon Springs that he is currently involved in. Edward also wouldn't provide any further details about the investigation.

Edward related he wished to have this incident documented.

At approximately 0200 hours, Cpl. Kanoski responded back to the bar in reference to a similar type complaint. Cpl. Kanoski advised me that Edward received another threatening phone call. Cpl. Kanoski stated two bar patrons, Justin and Teresa Amenson, observed a male subject outside of the bar near a dumpster talking on a cell phone. Cpl. Kanoski advised that Justin and Teresa didn't know if this male was the person making the threatening calls or not. The subject who was talking on the cell phone was identified as Scott Kaufman, who is not known to Edward, Justin, or Teresa.

Disposition: Case closed, pending further leads.
